Activity Report for 2009 Mental Health Center "SOMATO"

Mental Health Center "Somato" is the institution which delivers assistance to people with mental health problems and intellectual deficiencies, and their relatives as well.

Mental Health Center "Somato" was founded in September 2000 by the Civic Association "Somato", but in December 2004 it became Public Institution in conformity with the Decision of the Municipal Council Nr. 8/17 of 23. 12. 2004.

MHC "Somato" works on the community-based principles when delivering psychiatric assistance:

- The main focus is on passing from inpatient to outpatient services through creation of community- based centers as units of primary assistance;
- Creation of community-based services and redirection of people with mental disorders to these services;
- Preparing of the professional staff necessary for the activity in the conditions of the community-based psychiatry;

GOAL

The goal of the Center is to sensitize community with the regards to mental health problems, psychosocial rehabilitation of mentally-disabled people, representing these people in the society, creation of new alternatives in social assistance and elaboration of methods for solution of different problems their families face.

BASIC OBJECTIVES:

- Offer of active treatment and support of the disease and alimentation;
- Offer of temporary placement;
- Organization of all anniversaries and holidays;
- Organization of excursions with the beneficiaries of the center in the museums, theatres, cinemas and different places of interest;
- Psychological consultations for the beneficiaries and their families;
- Editing of flyers and promotional materials about mental health;
- Organization of workshops and round tables for parents, beneficiaries, relatives and community;
- Creation of the parental committee of the center's beneficiaries.

TARGET GROUP:

- People of the age of 18 and more;
- People with psychic deviations;
- People with mental retardation;
- People with non-psychotic disorders.

WORKERS:

Center's multidisciplinary team is made up of people with rich professional experience and knowledge, including psychologists, psychiatrists/psychotherapists, social assistants, medics with profound knowledge in mental health.

BASIC ACTIVITIES OF THE MHC "SOMATO"

I. Day Center:

There are three basic programs in the center, which determine its multilateral activity:

- Day Center;
- Temporary placement;
- Consultancy services;

The Day Center is open through 8.00 a.m. - 19.00 p.m. and delivers necessary services for all beneficiaries who attend the day center. There is an established schedule. Which is the following:

- 8.00 8.30 Receiving of the beneficiaries
- 8.30 9.30 Preparing and setting the tables
- 9.30 10.00 Housekeeping
- 10.00 12.00 Occupational therapy
- 12.00 13.30 Preparing and setting tables for lunch
- 13.30 14.00 Housekeeping
- 14.00 16.00 Occupational therapy
- 16.00 16.30 Dinner
- 16.30 18.00 Home-useful therapy
- 18.00 18.30 Preparing and setting tables for supper
- 18.30 19.00 Housekeeping and evening clearing
- 19.00 19.30 Beneficiaries leaving

In the Center everybody benefits of adequate treatment and correct alimentation, receives professional consultation. All activities relating to procurement, preparing and serving the meal, as well as housekeeping and garden activities, are performed without auxiliary people.

Occupational therapy comprises the following activities:

- Collage of plasticine and gypsum; confectioning of presents and souvenirs of different materials;
- Drawing with gouache, aquarelle, pencils;
- Theatre coterie, with plays for children and adults, pantomime;
- Dance coterie:
- Embroidering and crochet, needlework;
- Different excursions and fresh air and exercise.
 - II. **Temporary placement** is a program to support the families in difficult periods, when its members leave for business trips or vocations, or if they

do not have the possibility to take care of the member with special needs. The limited time is up to 3 months. Our experience shows that there is a necessity for non-stop support of people and their representation in different instances until their social or vital problems are resolved.

III. Consultancy services are offered people with mental health problems, their families and all people who need psycho professional consultation. Thus, the Center offers consultations of psychiatrists, psychotherapists and psychologists. These consultations are free.

Intervention delivered in the Center is complex and holistic; it has temporary character and is called *assisted case in mental health*.

Assisted case for the beneficiary of the Somato program

- 1. Intervention delivered in the Center is complex and holistic; it has temporary character and is called assisted case in mental health.
- 2. Assisted case is performed by multidisciplinary community team which consists of:
 - Psychiatrist/psychotherapist 1;
 - psychologist 2;
 - medical assistant/psychiatric nurse 2;
 - social assistant -2.
- 3. Duration of the intervention delivered in the Center is 90 days.
- 4. During this period the beneficiary has to fulfill an individual intervention plan, which consists of::
 - a. First psychiatrist consultation 1 duration 30 minutes;
 - b. First psychotherapist consultation 1 duration 45 60 minutes;
 - c. First evaluation of the beneficiary by psychologist 1 duration 40 minutes;
 - **a.** First evaluation of the beneficiary by psychiatric nurse 1 duration 20 minutes:
 - **b.** First evaluation of the beneficiary by social assistant 1 durations 40 minutes:
 - **c.** First evaluation of the beneficiary's family by social assistant 1 duration 30 minutes;
- a. repeated psychiatric consultation 2 consultations in a week duration 30 minutes:
 - b. individual psychotherapy 2 times a week duration 45 60 minutes (45 minutes for the meeting itself and 15 minutes to document the case);
- c. group psychotherapy 1 time a week participants 9-13 people 1 duration 1,5-2 hours. The applied methods psychodynamic, behavioral, cognitive, gestalt (Geschtalt) therapy, transactional analysis, systematic psychotherapy, music therapy, art therapy, diverse methods for relaxations, autogenic training, etc.

- d. individual consultation by the psychologist -2 consultations a week; duration 40 minutes:
- e. Consultations for personal development (group) -1 consultation per week; duration 1.5 2 hours;
 - f. family consultation to consolidate parental capacities; participants: family 2-5 people and beneficiary once in 2 weeks duration 1 hour;
- g. support and auto-support group with psychologist and psychiatric nurse; participants 9-13 people, once in 2 weeks; duration 1.5-2 hours;
 - h. repeated evaluation of the beneficiary by the psychiatric nurse -2 times a week; duration 10 minutes;
 - i. Occupational therapy and ergotherapy for professional orientation -5 times a week; duration 1.5 2 hours.

Identified problems and solutions to overpass them

Problems:

1. Absence of interest of certain beneficiaries towards delivered activities;

- 2. Conflicts between beneficiaries:
- 3. Few specialists for a big number of beneficiaries. As a result there appears limited possibility for individual work with each beneficiary;

Solutions:

- 1. More interesting organization of the activities, which corresponds the level of development of each beneficiary;
- 2. Instruction of the personnel in conflict management and in the specific aspects of every disability or disease;
- 3. Creation of support and auto-support groups, the fact which will contribute to the realization of activities with proper efforts.

Conclusions:

Substitution of the old way of development of social services with the new one - is a new aspect in development of integrated services of social assistance in Balti municipality. These services are planned to be created in close collaboration with the community.
